Brief description of the event (action), the occurrence (performance) of which, in the issuer's opinion, has an effect on the value of its securities: <i>expiration of the term set for submission of offers by prospective purchasers of documentary inconvertible interest bearing exchange bonds of Transneft in bearing form with mandatory central keeping, series BO-001P-03 (hereinafter referred to as the "Exchange Bonds") placed within the scope of the Exchange Bond Program, identification number 4-00206-A-001P-02E of 06 April 2016 (hereinafter referred to as the "Exchange Bond Program") with an offer to conclude Preliminary Agreements as defined in the Exchange Bond Program.</i></p>
