Brief description of the event (action) the occurrence (performance) of which influences, in the Issuer's opinion, the value of its securities: <i>expiry of the term for submission of offers by potential acquirers of documentary inconvertible interest bearing exchange bonds in bearing form with mandatory central keeping, series BO-001P-04 of Transneft (hereinafter referred to as the "Exchange Bonds") placed under the Exchange Bonds Program with identification number 4-00206-A-001P-02E dated 06 April 2016 (hereinafter referred to as the "Exchange Bonds Program"), with offer to conclude the Preliminary Contracts, as this term is determined in the Exchange Bonds Program.</i></p> <p>2.2.
