The category of the transaction (major transaction, which is not large-scale; large-scale transaction; interested party transaction; major transaction which is at the same time an interested party transaction):</b> a major transaction which is not large-scale.</p> <p><b>2.4. The type and scope of the transaction:</b> Type of the transaction: an oil transportation services agreement. Scope of the transaction: rendering of services by Transneft (for a fee) consisting in transportation of oil complying with the requirements of GOST R 51858-2002 (oil) using the trunk pipeline system of the Russian Federation.</p> <p><b>2.5. The content of the transaction, including the civil rights and obligations to be established, changed or terminated by the effected transaction:</b> Within the period from 01 January 2018 through 31 December 2018 Transneft shall render oil transportation services to OJSC "Surgutneftegas" (the Shipper) in the amount of about 61,177,651 thousand tons beneficially owned by the Shipper or owned by it on other lawful grounds, in particular in mixture with the oil of other Shippers, using the trunk pipeline system of the Russian Federation and the Shipper shall pay for the services rendered to it.</p> <p><b>2.6. The maturity date for the obligations under the transaction, parties and beneficiaries to the transaction, the amount of the transaction in monetary terms and as percentage of the value of the assets of the issuer:</b> <b>Maturity date for the obligations under the transaction:</b> from 01 January 2018 through 31 December 2018, in respect of non-performed obligations — until their complete performance. <b>Parties and beneficiaries to the transaction:</b> Transneft, the Operator (according to Decree of the Russian Government No. 218 dated 29 March 2011); OJSC "Surgutneftegas", the Shipper; there are no beneficiaries to the transaction. <b>The amount of the transaction in monetary terms and as percentage of the value of the assets of the issuer:</b> RUB 117,472,153 thousand (rubles) (including VAT), 10.55%.</p> <p><b>2.7 The value of the assets of the issuer as of the date of the end of the last accounting period preceding the effecting of the transaction (entering into the agreement):</b> RUB 1,113,386,931 thousand (rubles).</p> <p><b>2.8. Date of entering into the transaction (agreement):</b> 27 December 2017.</p> <p><b>2.9.
