Brief description of event (action), occurrence (performance) of which influences value of its securities, according to the issuer: <b><i>Expiration of the period for forwarding offers by potential buyers of documentary inconvertible interest-bearing exchange bonds in bearing form with mandatory central keeping, series BO-001P-10 of Transneft (hereinafter referred to as the "Exchange Bonds") placed under the Exchange Bonds Programme with identification number 4-00206-A-001P-02E dated 06 April 2016 (hereinafter referred to as the "Exchange Bonds Programme") with the proposal to enter into Preliminary Contracts as this term is defined in the Exchange Bonds Programme.</i></b></p> <p>2.2.
