Transaction type and subject:</b> Transaction type: oil transportation services contract. Transaction subject – Transneft’s rendering paid services on transportation of oil complying with the requirements of GOST R 51858-2002 (oil) through the trunk pipelines system of the Russian Federation.</p> <p><b>2.5. The transaction content, including civil rights and obligations, to establishment, alteration or termination of which the performed transaction is oriented:</b> Transneft shall be obliged to render within the period from 01 January 2019 to 31 December 2019 services to Surgutneftegaz (the Consignor) on oil transportation in the amount of 61,170.164 thousand tons, belonging to the Consignor on the basis of the right of ownership or on another legal basis, including in mixture with other Consignors’ oil, through the trunk pipelines system of the Russian Federation, and the Consignor shall be obliged to pay for the rendered services.</p> <p><b>2.6. Period of performance of obligations under the transaction, parties and beneficiaries under the transaction, transaction amount in monetary terms and in percent from the cost of assets of the issuer:</b>  <b>Period of performance of obligations under the transaction:</b> from 01 January 2019 to 31 December 2019, and as regards outstanding obligations – until their performance.  <b>The parties and beneficiaries under the transaction:</b> Transneft – the Operator (in accordance with the Regulation of the RF (Russian Federation) Government dated 29 March 2011 No. 218); Surgutneftegaz – the Consignor; beneficiaries – absent.</p>
